Report on Limited Review of the Unaudited Financial Results of the Company for the 3rd Quarter/Nine Months ended 31st December, 2018

1. We have reviewed the accompanying statement of unaudited financial results of Kilburn Office Automation Ltd. (the "Company") for the Quarter/Nine Months ended 31st December' 2018 (the "Statement") attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. CIR/CFD/FAC/62/2016 Dated July 05, 2016.


Notes
